Since 2021, TGEU has been developing a series of resources focused on the anti-gender movement. This work includes:

- Research to understand who anti-gender actors are and how they organise
- How to counter their influence through strategic communications
- Developing safety and security guidance for activists and organisations fighting for trans rights.

TGEU has also developed a set of new practical tools and templates to support rapid responses when anti-trans incidents occur.

This hub is a private space for our members to explore the knowledge and skills-based information gathered across all TGEU's resources, training information, and tools relating to the anti-gender movement.

Landscape Analysis: What we know on anti-gender movement measures and actors targeting trans people across Europe and Central Asia

This report aims at providing an overview of the available literature, public resources, and information tracking how the actors and tactics of the anti-gender movement are targeting trans people. In providing this overview, the report has two objectives.

Firstly, it draws attention to the rise in organised anti-gender and anti-trans actors across Europe and Central Asia as a point of concern for trans organisations, activists, and others working to support trans communities.

Secondly, it identifies gaps and trends in the literature and shares key information on the patterns observed in where and how anti-gender and anti-trans actors are striking; their tactics, connections, arguments, and level of impact. It also highlights gaps in research, knowledge, and publicly-available literature on actors specifically targeting trans people, and the need for greater academic research into these areas.

Supporting Those Who Speak Up for Trans Rights: Safety and Security Toolkits

Trans people, especially those who engage in activism, tend to be at higher risk of backlash. These toolkits are designed to address that. They include material tailored to threats that trans activists or organisations may face. They can be used to help create safe living and working environments.

The toolkits draw on collective knowledge from existing safety resources within and outside the trans community. Inside, you'll find many adaptable resources. These cover general safety and security principles and concepts. They go on to lay out practical steps to identifying plans relevant to trans-specific situations. There are also a set of handouts which can be used as standalone tools and exercises.

Key topics include:

- How to prevent safety and security incidents from occurring
- How to respond to incidents if they occur
- Ways to mitigate risks and threats through various planning tools.

Practical templates and guidance for responding to urgent incidents

A new set of practical templates for responding rapidly to urgent incidents as soon as they happen. These were developed to meet the needs expressed by members for accessible templates which could be used with little introduction, for typical urgent actions, and with key information already included.

The resources include:

- Protocols for legal or policy changes, and for activists facing personal risks.
- Case study template – top level questions to capture information as it happens and write up quick case studies.
- Guidance: how to create quick reference guides to communicate rapidly with key stakeholders – to pull together important information ahead of anticipated incidents occurring so that you can respond quickly when the moment happens.
- Example procedures for communicating with important stakeholders – guiding good practice and templates, including examples of the following documents:
 - A letter addressing a Minister of State,
 - A letter and email addressing a parliamentarian,
 - A press release and cover email,
 - An email addressing the CEO of a feminist organisation/board of an international donor organisation.

Messages That Build Support for Transgender Rights: A Toolkit for Effective Communication Strategies

The communication strategies in this toolkit are geared at educating the ‘moveable middle’ about trans people. The moveable middle refers to people who do not already hold a strong opinion on a topic, in this case, trans rights.

The communication strategies it covers recognise that language around trans activism can alienate these audiences. This toolkit provides an overview of how to develop messages, with concrete goals and audiences in mind. It also lays out several tested communication strategies, and how to use them.

This toolkit includes two communications approaches:

- [The Heartwired Approach](#) – this approach relies on psychology. It uses a person’s existing values to help them learn about and understand trans lives and experiences.
- [Race Class Gender Narrative](#) – this approach seeks to reach the moveable middle without alienating existing supporters. It specifically builds on alliances across and between race, class, and gender movements.

TGEU conducted several trainings with members and other organisations on the principles of communications to build support for trans rights amongst moveable middle audiences. And how to apply these principles in different contexts.

Trans Rights Are Human Rights: Dismantling Misconceptions About Gender, Gender Identity & the Human Rights of Trans People

This publication provides messaging to respond to some common narratives fuelling anti-trans movements. It is especially useful to combat anti-trans narratives used to justify the rollback the rights of trans people. These arguments focus primarily on the fundamental opposition between trans rights and the rights of women and children. They are misleading and deliberately based on falsehoods or half-truths.

The information and speaking points included in this publication are being used extensively by trans activists in Europe. They are essential to their efforts to combat anti-trans narratives and actors.

It is designed for policymakers seeking to improve their ability to argue in favour of the human rights of trans people. It also includes key points for activists who work with policymakers.
