## New hybrid format

This year, for the first time we will hold a hybrid General Assembly with the option of participating online for our members who can not attend in person. The event will take place on **Saturday 23 November, 14:30-18:00 CET**, during the TGEU European and Central Asian Trans Council, in Malta.

TGEU's Board and staff are working hard to organise a successful and community-driven hybrid GA which will include TGEU's most important elections including its Board, Co-Chairs and Auditors will take place during the event. Members will have the opportunity to share insights and feedback on TGEU's organisational budget, policies and new strategy plan. Join us and shape TGEU's future!
